ITINERARY

Day 1 - Sep. 13: Depart U.S.A.

Our pilgrimage begins as we depart Los Angeles for Madrid on Iberia Airlines. Meals and refreshments will be served aloft.

Day 2 - Sep. 14: Arrive Madrid

Upon arrival in Madrid we will be met by our tour manager and transfer to our hotel for rest. The remaining of the day is free.

Day 3 - Sep. 15: Madrid

A full day tour of Madrid will show some of the history and traditions of Spain. We will start with a visit to the Prado Museum with its masterpieces of El Greco, Goya, and Velasquez and then we will visit the Royal Palace, the University with Cervantes' monument, Puerta del Sol and Retiro Park.



Day 4 - Sep. 16: Madrid / Salamanca

Depart Madrid for Segovia whose Cathedral is considered the last Gothic church in Spain. Here we will pay our respects to a great Carmelite, St. John of the Cross who served as spiritual director to St. Theresa of Avila. Continue to the walled city of Avila, made famous by St. Teresa, another Doctor of the Church. Visit the Monastery of the Incarnation where St. Teresa spent many years of her life. Then travel to Alba Tormes to visit the Carmelite Convent which contains St. Teresa's incorrupt arm and heart. Proceed to Salamanca, one of the most prestigious university town in the world. Enjoy a sightseeing tour including visits to the Plaza Mayor which is regarded as one of the most attractive squares in Spain and see the Cathedral from outside.

Day 5 - Sep. 17: Salamanca / Santiago de Compostela

Depart Salamanca and drive to Orense which has been famous since Roman times for its warm springs. Orense was the main way to Santiago de Compostela, and here we will visit its Cathedral whose carved doorways were

modeled as Santiago's Door of Glory. Continue through the Castile-Leon region to Santiago de Compostela. Tradition tells us that St. James the Apostle journeyed to Spain in 40 A.D. to spread the Gospel as far as possible. He died a martyr's death after returning to Jerusalem, and his remains were eventually returned to Spain and buried in this city.



Day 6 - Sep. 18: Santiago de Compostela

This morning we will enjoy a complete tour of Santiago de Compostela. Visit the impressive Cathedral which is considered to be one of the most prominent pieces of architecture in Europe. After Mass, climb the stairs behind the altar to visit the crypt, where a silver urn contains the relics of St. James. See the Portico de la Gloria (Gateway to Heaven), a unique masterpiece. Walk to the top of the Cathedral for a panoramic view of this glorious city. We will also visit the museum in the cloister adjoining the Cathedral. The remainder of the afternoon will be free.


Day 7 - Sep. 19: Santiago Compostela / Burgos

Following breakfast depart for Lugo and view the Roman wall which was built in the 3rd century to protect its citizens from invaders and is now a protected UNESCO World Heritage Site. Continue to Leon to visit its magnificent Gothic Cathedral whose stained glass windows have led people to say that it is made of more glass than stone. We then drive to Burgos, the cradle of Castille and the old capital of Spain.

Day 8 - Sep. 20: Burgos / Lourdes

Depart for Loyola and have a special Mass at Loyola Sanctuary. Pray at the Basilica where our Lady appeared to St. Ignatius with the Christ child, the founder of the Jesuit order. We then depart towards the Spanish-French border to Lourdes, one of the great pilgrimage shrines in the world. It was here where Our Lady appeared to

Bernadette in 1858 proclaiming herself the “Immaculate Conception.” This evening we will participate in the Blessed Sacrament Procession and the Candlelight Procession.



Day 9 - Sep. 21: Lourdes

Today we will have all day to experience the special atmosphere of this beautiful town. Attend Mass at the Grotto of Massabielle, visit the Basilica of St. Pius X, see the house where Bernadette lived during the Apparitions, and visit the sites where miraculous cures have taken place. After dinner, we will join the Candlelight Procession.

Day 10 - Sep. 22: Lourdes / Zaragoza

We depart Lourdes and drive across the French-Spanish border to Zaragoza which is the chief city of Aragon and has traditions connected with the story of St. James. Here we will visit the Shrine of Our Lady of Pilar where the Blessed Virgin appeared to St. James.



Day 11 - Sep. 23: Zaragoza / Barcelona

After Mass we will depart Zaragoza and follow St. Ignatius' path to the Sanctuary of Our Lady of Montserrat, the spiritual heart of Catalonia and home to the dramatically set Benedictine monastery. For 700 years this Marian shrine has attracted thousands of pilgrims from around the world. We pause here to visit the Black Madonna of Montserrat, probably Spain's most fervent devotion to the Blessed Mother. We then travel to vibrant Barcelona, our home for the next two nights.



Day 12 - Sep. 24: Barcelona

Today we will visit Santa Maria del Mar (Our Lady of the Sea), a lovely and elegant church that dates from the mid-14th century. Then visit Barcelona Cathedral which is a magnificent 14th-century building in the heart of the Gothic Quarter. Next we will visit Gaudi's La Sagrada Familia which is a beautiful, unfinished basilica of impressive proportions. Continue on to Tibidabo Hill where we will visit the Church of the Sacred Heart and see a statue of Christ whose extended arms overlooking Barcelona reminds one of Rio de Janeiro.

Day 13 - Sep. 25: Barcelona / U.S.A.

This morning we will transfer to Barcelona Airport to catch our return flight home.

GENERAL INFORMATION AND CONDITIONS

Reservations and Payment: Please complete the attached Reservation Application and return it with your deposit of \$300.00 per person at the time of booking. Final payment is due 65 days prior to departure.

Cancellations: All cancellations must be in writing. The following per person cancellation charges will apply: If canceled 91 days or more prior to departure, a \$50.00 administrative fee will be charged. If canceled 90 - 61 days prior to departure, \$250.00 will be charged. If canceled 60 - 31 days prior to departure, \$450.00 will be charged. If canceled 30 - 7 days prior to departure \$700.00 will be charged. No refunds will be made within 6 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable unless you have been advised otherwise at the time of your booking. Additional cancellation charges may apply depending upon the cancellation terms of our suppliers.

Refunds: Subject to the foregoing Cancellation Terms, upon cancellation of travel related services, all sums paid to George's International Tours for such services will be promptly returned to the passenger, provided the passenger has not caused such cancellation and is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where George's International Tours has remitted the payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, George's International Tours agrees to provide passenger with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

Trust Account Disclosure: California law requires certain sellers of travel to have a trust account or bond. George's International Tours has such a trust account.

Travel Consumer Restitution Corporation ("TCRC"): George's International Tours is a participant in the Travel Consumer Restitution Corporation ("TCRC"). You, the passenger, may request reimbursement from TCRC if the Seller of Travel was registered and participating in the TCRC at the time of sale and the passenger is located in California at the time of payment. Please be advised that passengers purchasing from outside of California are not covered by the TCRC. Eligible passengers may file a claim with TCRC if the passenger is owed a refund of more than \$50 for transportation or travel services which the Seller of Travel failed to forward to a proper provider or if such money was not refunded to you when required. The maximum amount which may be paid by the TCRC to any one passenger is the total amount paid on behalf of the passenger to the Seller of Travel, not to exceed \$15,000. A claim must be submitted to the TCRC within six months after the scheduled completion date of the travel. A claim must include sufficient information and documentation to prove your claim and a \$35 processing fee. You must agree to waive your right to other civil remedies against a registered participating Seller of Travel for matters arising out of a sale for which you file a claim with the TCRC, if you were located in California at the time of the sale. You may request a claim form by writing to: Travel Consumer Restitution Corporation, P.O. Box 6001, Larkspur, CA 94977-6001; or by faxing a request to 415-927-7698.

Travel Documents: A passport with a minimum of 6 months validity remaining is required of all U.S. citizens. U.S. citizens do not require visas for entry to the countries being visited on this tour. If you are not a U.S. citizen, please call to find out if you need a visa. George's International is not responsible for visas or passports.

Tour Cost: All quoted prices are based upon fares, tariffs and currency exchange rates at the time of printing and are subject to change at any time. Should the minimum number of 20 tour members not be reached, the right is reserved to increase the tour cost accordingly.

Tour Documents and Tickets: Final tour documents are mailed, provided we have received full payment, within 3 weeks of departure.

Baggage: Each passenger is allowed one checked bag and one carry-on. You will be responsible for paying to the airline any additional charges for additional checked baggage or overweight baggage (if excess weight is permitted). George's International Tours is not responsible for lost, damaged or stolen baggage.

Air Transportation: Air travel is in economy class on Iberia Airlines (or any other IATA carrier). Fares are based upon levels in effect at the time of printing. Fares and flight schedules are subject to change without notice.

Hotels: Accommodations are based on double occupancy rooms. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking.

Travel Insurance: We strongly recommend that you have comprehensive travel insurance. Insurance may be purchased directly through George's International Tours and registration forms will be provided upon receipt of your deposit or you may purchase online at www.georgesintl.com.
